With new research, strategic events, and powerful partnerships, IFIP and our partners helped shape key UNPFII outcomes.

To cap it off, building upon years of foundational work - IFIP launched Reframing Philanthropy: Indigenous-Led Funds Governance Models and the Rooted in Trust toolkit, showcasing the leadership of Indigenous-Led Funds.

#### IFIP at the 24th Session of the UN Permanent Forum on Indigenous Issues (UNPFII)

The International Funders for Indigenous Peoples (IFIP) participated in the first week of the 24th Session of the UN Permanent Forum on Indigenous Issues (UNPFII), held from April 21 to May 2, 2025. This year's theme, "Implementing the United Nations Declaration on the Rights of Indigenous Peoples (UNDRIP) within UN Member States and the UN system," underscored the urgency of realizing Indigenous rights amid climate change, biodiversity loss, and the need for culturally rooted development approaches.

Throughout the week, IFIP engaged with its members, Indigenous Peoples organizations, actively supporting advocacy efforts and facilitating key engagements across the Forum.

One major highlight was IFIP's engagement in promoting Indigenous midwifery as a vital and autonomous practice. In partnership with the W.K. Kellogg Foundation and the Continental Alliance of Indigenous Midwives of the Americas, IFIP co-hosted a series of events including a full-day strategy meeting and an official UN side event, "Indigenous Midwifery & Rights: Progress, Gaps & Solutions." IFIP facilitated the participation of 18 Indigenous midwives from seven countries and supported the Alliance in its public presentation of the Declaration promoting Indigenous midwifery as an essential health service, Furthermore, Alliance member, María Quiñelén, from Chile delivered a statement at the official session.

This advocacy yielded a major success, UNPFII official report (Paragraph 29) included a groundbreaking recommendation recognizing Indigenous midwifery as an autonomous ancestral practice and calling on Member States and agencies such as WHO and PAHO to finance, decriminalize, and integrate it into national health policies.

#### **UNPFII** Highlights continued

In connection to the leadership role IFIP is playing on raising the visibility and strengthening the ecosystem of Indigenous Led Funds globally. IFIP hosted a well-attended side event on the role of Indigenous-Led Funds in advancing the implementation of the UN Declaration on the Rights of Indigenous Peoples (UNDRIP). In addition, IFIP facilitated and coordinated with the Ereto Solidarity Fund, Kipok Fund, AYNI Fund, and Fundo Rutî, to deliver a formal intervention on the importance of financing Indigenous Peoples' participation across multilateral systems. This joint advocacy effort elevated calls for direct, just, and long-term funding to Indigenous Peoples' organizations and initiatives.

IFIP was also thrilled to launch our newest body of knowledge, IFIP's new research report, Reframing Philanthropy: Indigenous-Led Funds Governance Models, highlighting governance models and funding pathways grounded in Indigenous values. This new report explores the governance structures, values, principles, and operational realities of 23 Indigenous Led Funds from the Arctic, Africa , Asia, Pacific, North America and Latin America. The report will be accompanied by a toolkit Rooted in Trust: A Funders' Toolkit for Strengthening Indigenous-Led Funds.

IFIP was pleased to contribute towards the realization of the UNPFII reception at the UN Headquarters, joining other Indigenous organizations to make the reception possible.

IFIP also joined an event hosted by Open Society Foundations and the Permanent Mission of Colombia on Coca is a Plant – Film, Art, Indigenous Rights & the Coca Leaf. The event highlighted the Coca plant's 8,000-year history of cultural, medicinal, and spiritual use by Indigenous Peoples of the Amazon and Andes and called for international policy changes to remove its narcotic classification and uphold Indigenous rights.

#### Rooted in Trust: Understanding the Indigenous-Led Funds Governance Scan and Toolkit for Funders

Indigenous-Led Funds (ILFs) are gaining recognition as transformative models of resource redistribution that prioritize Indigenous governance and self-determination. These funds are not simply mechanisms for allocating grants; they are expressions of self-determination, deeply grounded in Indigenous knowledge systems and community accountability. As their visibility and impact continue to grow, so too has the need for deeper understanding—by both funders and the philanthropic field more broadly—about how ILFs function, how they lead, and what makes their approach distinct from mainstream philanthropic institutions.

IFIP recently published a new body of knowledge, the Reframing Philanthropy: <a href="Indigenous-Led Funds Governance Models">Indigenous-Led Funds Governance Scan</a>, developed by the International Funders for Indigenous Peoples (IFIP), explores the governance structures, values, principles, and operational realities of 23 Indigenous Led Funds from the Arctic, Africa, Asia, Pacific, North America and Latin America. The purpose of the scan is to highlight Indigenous leadership and offer insight into how ILFs are redefining governance and accountability in ways that are grounded in Indigenous worldviews, and to articulate their practices in ways that could be shared with both peer ILFs and philanthropic allies.

One of the key contributions of the scan is its articulation of how Indigenous-Led Funds have retooled philanthropic systems to move resources more justly and effectively by centering representative governance, with decision-making processes that include Elders, youth, and grassroots voices and being guided not by donor priorities but by community-defined goals.

To translate the insights of the Governance Scan into practical support for the wider field, IFIP developed a companion resource: Rooted in Trust: A Funders' Toolkit for Strengthening Indigenous-Led Funds. This toolkit captures the core values, lessons, and recommendations shared by ILF leaders during the scan. It introduces a framework based on the 5Rs of Indigenous Philanthropy: Respect, Relationships, Responsibility, Reciprocity, and Redistribution. These are not abstract values; they are living practices that shape every aspect of ILF operations and partnerships.

#### Indigenous Youth Manifesto & Funder Dialogue

On June 10, IFIP hosted a virtual session titled "Empowering the Future: Indigenous Youth and Funders' Dialogue for Transformative Change." The session brought together more than 110 Indigenous youth leaders and funders to explore how to strengthen support for Indigenous community-driven initiatives. This session centered upon the Indigenous Youth Manifesto that was co-created by the youth at the 2nd Indigenous Youth Dialogues at our Global Conference in Kenya, with the support of Mastercard Foundation.

#### Key highlights included:

- Indigenous youth called for direct support, long-term investment, and trust in community-led solutions.
- Speakers shared personal experiences navigating the complexities of funding and advocacy while defending their cultures and territories.
- 3. Funders reflected on the importance of **flexibility**, **trust-based philanthropy**, and **centering Indigenous knowledge** in funding strategies.
- 4. There was a strong call to reimagine funding models, dismantle colonial structures, and build equitable partnerships.
- 5. The importance of **intergenerational knowledge-sharing** and **youth leadership** rooted in land, identity, and language was emphasized.

#### IFIP in International Forums

#### IFIP at Bonn Climate Conference 2025

IFIP attended the Bonn Climate Conference 2025 from 16 – 19 June and Indigenous Peoples Caucus pre meetings on June 14-15, 2025. The Bonn Climate Conference is UNFCCC mandated annual intersessional meetings happening between the previous COPs and upcoming COPs to review the technical improvements of climate actions and implementation of climate agreements and shape the key decisions and agenda to be finalized at the upcoming COPs.

The 62nd session of the Subsidiary Bodies of the UNFCCC, also known as SB62 was important to Indigenous Peoples because it gave Indigenous Peoples opportunity to closely follow and make recommendations for key decision items related to Indigenous Peoples such as Climate Finance, Global Goal on Adaptations, Just Transition and Non-Market Based Approaches.

Some of the key advocacy demands by the Indigenous Peoples during the SB62, which will be carried forward to the COP30 are as follows.

- 1. Operationalization of direct access of funding for mitigation, adaptation and loss and damage for Indigenous Peoples.
- 2. Explicitly reflect the rights, knowledge, and governance systems of Indigenous Peoples in the development of Global Goal on Adaptation,
- 3. Recognition of Indigenous Food systems as viable alternative to industrial food systems and its integral role in mitigation and adaptation strategies. Rejecting the promotion of false solutions and valuing the Free Prior and Informed Consent (FPIC) in just transitions projects.

In addition to the key negotiation's issues, Indigenous Peoples through the Indigenous Peoples Caucus raised the issue for inclusive participation of Indigenous Peoples in COP30 that acknowledges the central role of Indigenous Peoples in climate action, allocation of COP30 badges and logistical arrangements with the COP30 President Designate, André Aranha Corrêa do Lago. IFIP closely attended and supported advocacy through engagement with the IPs caucus and members and partners attending the conference.

#### Call for Fundraising for COP30 Indigenous Peoples Pavillion

The International Indigenous Peoples Forum on Climate Change (IIPFCC), the primary channel for Indigenous Peoples' engagement in UNFCCC has geared up for supporting participation of Indigenous Peoples in COP30.

The IIPFCC is currently fundraising towards the Indigenous Pavillion for COP30. The pavilion is used as a platform for Indigenous Peoples to collectively engage in the COP30 through hosting side events, IPs caucus daily meetings, and media engagements. #### 4TH International Conference on Financing for Development (FFD4)

IFIP attended the UN Financing for Development Conference as part of the WINGS delegation of philanthropic networks attending to support action by the sector to foster an enabling environment, ecosystem investment on a localization agenda, and growing local cultures of giving to supplement international development assistance. IFIP also participated on the side event The Rights of Indigenous Peoples in the Renewed Global Financing Framework organized by Fondo para el Desarrollo de los Pueblos Indígenas de América Latina y el Caribe FILAC, International Labor Organization (ILO), and the World Bank.

The FFD4 UN event focused on reforming the global financial system to better support sustainable development, particularly the <u>Sustainable Development Goals</u> (SDGs). FFD4 was attended by governments, multilaterals, bilaterals, businesses, philanthropy who gathered to discuss the pressing changes and realities in front of us due to the significant reduction of international development cooperation assistance, which risks impacting the progress social movements have made for the betterment of societies Philanthropic foundations attending and speaking on panels expressed hesitation about being expected to fill the gap left by donor countries that have decided to reduce funding for development assistance programs.

The <u>Sevilla Commitment</u> was adopted with a focus on mobilizing private finance, blended finance, social bonds, and debt swaps but without much clarity on how any of the proposed solutions will reach Indigenous Peoples, on the final document, Indigenous Peoples were mentioned under private capital noting under bullet the participation of Indigenous Peoples: (vii) To include participation of Indigenous Peoples and local communities as well as relevant stakeholders in decisions affecting them.

#### IFIP honored by Indigenous Movement in Asia

IFIP was deeply honored to be recognized by the <u>Asia Indigenous Peoples Pact Foundation</u> (AIPP) during its Ninth General Assembly, held in early June 2025 in Chiang Mai, Thailand. AIPP, the only regional network of Indigenous Peoples in Asia, is dedicated to promoting and defending indigenous Peoples' rights and human rights across the region. The Assembly, convened under the theme "Being Indigenous in Asia: Common Identity, Shared Struggles, Collective Futures" brought together its members along with its key regional and global partners.

During the closing Ceremony, IFIP received a special award in recognition of its longstanding solidarity, continued partnership and commitment to Indigenous-led movements across the region. The award statement read: "Your unwavering support has shaped our journey. With deep respect, we honor your integrity and solidarity in advancing the rights and dignity of Indigenous Peoples in Asia".

#### Celebrating Solidarity: FIMI Honors IFIP at Its 25th Anniversary Global Gathering

In June 2025, the International Indigenous Women's Forum (FIMI) held a Global Indigenous Women's Gathering in Lima, Peru, to celebrate 25 years of leadership and resilience. The two-day event, held on June 20–21, brought together Indigenous women from across the globe to commemorate the collective struggles for the individual and collective rights of Indigenous Women and Girls, to honor their shared histories, recognize achievements, and reaffirm their commitment to transforming the lives of Indigenous girls, women, and women with disabilities.

During this powerful gathering of Indigenous Women, funders and other allies, FIMI recognized key partners and allies who have journeyed with them over the years. Among those honored was the International Funders for Indigenous Peoples (IFIP) and our Executive Director, Lourdes Inga. The recognition of IFIP by FIMI was a heartfelt acknowledgment of a long-standing relationship rooted in trust, shared values, and a commitment to Indigenous self-determination. Winnie Kodi, IFIP's Indigenous Led Funds Manager accepted the award on behalf of IFIP from Tarcila Rivera Zea. FIMI's Board President.

FIMI's recognition of IFIP and other allies affirms the profound value of long-term partnerships with Indigenous-led organizations. It also exemplifies what it means to co-create pathways that honor Indigenous women's leadership while advancing broader systemic change and the enduring impact that can be achieved when funders move beyond transactional relationships to embrace solidarity, accompaniment, and accountability. These relationships are not built overnight, they are cultivated through decades of shared learning, active listening, and deep care. For years IFIP and FIMI have walked alongside one another, forging a relationship that has been both strategic and deeply relational that has evolved through shared participation in regional and global convenings, plus shared advocacy efforts.

For IFIP, these moments of recognition serve as both an honor and an affirmation. It strengthens our resolve to continue advancing Indigenous self-determination and leadership across the philanthropic sector. It reminds IFIP of the importance of staying rooted in community and committed to amplifying the voices, visions, and solutions of Indigenous Peoples globally.

Check out the latest Member News - from powerful new programs and advocacy efforts to leadership transitions and cultural celebrations that showcase the strength and vision of Indigenous communities around the world.

**The MacArthur Foundation** has launched a new program dedicated to working in good relations with Native communities. Rooted in years of listening, unlearning, and building meaningful relationships, the program reflects a long-term commitment to moving at the pace of trust. In a message from President John Palfrey, the Foundation highlights that this work is still unfolding and intentionally leaves space for future leadership to help shape its direction.

Amazon Watch shared that a recent delegation of Waorani and Kichwa Pakkiru leaders from Ecuador to Sacramento was a success! The group traveled to California to spotlight the link between the state's Amazon crude imports and deforestation and rights violations in the Ecuadorian Amazon. Their powerful advocacy helped prompt the California state Senate to introduce a resolution to end the state's import of crude oil from the Amazon. The visit comes as Ecuador plans to open new oil blocks, despite a 2023 referendum and a 2025 Inter-American Court ruling protecting Indigenous lands. Amazon Watch also just released a major report on Ecuador's attempt to auction off Indigenous territories for oil drilling."

The Cultural Conservancy recently received a coveted Lush Spring Prize bringing home the Indigenous Knowledge & Wisdom Award. Founded in 1985, The Cultural Conservancy's mission is to protect and revitalize Indigenous cultures through the direct application of traditional knowledge and practices on ancestral lands. Ford Foundation recently announced that Heather Gerken will become the 11th president of the Foundation in November of 2025. Heather is the current dean of Yale Law School and is an expert on constitutional law and democracy. She will be succeeding President Darren Walker who ably served in this position for over ten years. IFIP acknowledges Darren for Ford Foundation's commitment to funding Indigenous Peoples. We also look forward to welcoming Heather in the coming months, with an emphasis on the important role the Ford Foundation has played in supporting Indigenous Peoples, and to encourage a renewed commitment to funding Indigenous Peoples under her leadership.

So far, we have funded over 50 enterprises including cooperatives and associations. Mas Foundation - MAS Foundation is uniquely structured through a **Te Tiriti o Waitangi** partnership, sharing leadership between **Tangata Whenua** (Indigenous peoples of Aotearoa) and **Tangata Tiriti** (Treaty partners). This model ensures Māori knowledge, aspirations, and solutions are central, and drives a high-trust, relational grant-making approach grounded in the values of **kia kaha, kia māia, kia manawanui** (be bold, be brave, be steadfast) and tika, pono me te aroha (do what is right with integrity, fairness, and compassion). Believing enduring solutions come from within communities, MAS Foundation prioritizes co-designed, culturally grounded strategies to address inequities. As they say: "E fofō e le alamea le alamea."

Their current strategy, Te Tikitiki a Taranga – Supporting Whānau in the Early Years, focuses on the first 2,000 days of a child's life – from conception to age five – recognizing it as a critical window for lifelong wellbeing. Shaped by listening deeply to whānau and communities, this kaupapa invests in whānau-led initiatives that uphold cultural safety, autonomy, and intergenerational impact. MAS Foundation's three priority areas are: 1) **Health & Wellbeing**, including maternal health and nutrition; 2) **Family Violence & Trauma Prevention**; and 3) **Early Learning & Whānau Empowerment**, which strengthens resilience and long-term capability. **Oranges & Sardines Foundation** - supports a safer, more equitable world where creativity fosters deeper understanding of life and the earth. The Foundation centers First Nations knowledges and experiences, actively works to end gender inequality, and embraces creativity as a force for collaboration and positive change. With a strong commitment to listening, learning, and collective action, it envisions a peaceful and prosperous future.

The Foundation dedicates **50% of its funding to First Nations-led initiatives**, partnering with movements and organizations such as Common Threads, Original Power, Seed, Waminda, and many more. It supports First Nations arts in all forms and promotes cultural development across the arts sector. As members of Mannifera and the Australian Environmental Grantmakers Network, Oranges & Sardines funds both grassroots and large organizations without a public platform, choosing instead to uplift the voices and work of the communities it serves.

#### **Expanding Indigenous Philanthropy in Community**

Recently IFIP participated in the PHILEA Forum (Philanthropy Europe Association) from June 2-5, 2025, in Lisbon, Portugal. The theme of the event was "Power and Equality: A Balancing Act", with more than 800 participants from Europe and around the world, it was an inspiring, timely and highly engaging experience. Several IFIP members and partners were also in attendance and many promising new connections were made.

One of the highlights was the <u>opening plenary speech of Françoise Moudouthe</u>, CEO, African Women's Development Fund, who powerfully reminded attendees, that the time is now to meet this moment. She challenged philanthropy to think like a feminist and center justice and reminded us that when the goal is justice, you must center those that are best placed to make justice happen - the movements, and that philanthropy must fund their agenda to just be and do. Her closing words were to fund like a feminist – to be responsive not reactive. To transform philanthropy so that philanthropy can in turn transform the world, to look to the movements for inspiration as it is time to re-strategize, it is not the time to freeze... as delays are deadly in this time, and she closed with sharing the most important lesson she learned from African feminists, it's to keep going!
